

Ordinance
No. 22

WHEREAS, a petition, signed by two-thirds of the property owners in the area hereinafter described, has been duly presented to the Commissioners of Leonardtown, requesting that the boundaries of the corporate limits of the Town of Leonardtown be extended so as to incorporate the said area within the corporate limits of the Town of Leonardtown; and

WHEREAS, the Commissioners of Leonardtown, by virtue of the power and authority vested under the provisions of Section 95B of Article 19 of the Code of Public Local Laws of Maryland (Acts of 1945), is empowered, in its discretion, to extend said boundaries to incorporate the said area; and

WHEREAS, the said Commissioners of Leonardtown has determined to extend said boundaries in the manner aforesaid, believing the same to be in the interest of the residents of the said Town of Leonardtown and the area described herein:

Now therefore be it Resolved and Ordained by the Commissioners of Leonardtown, under and by virtue of the aforesaid power and authority, that the boundaries of the Town of Leonardtown be, and the same are hereby extended to include the following described area: Beginning for the same at the northeast boundary of Leonardtown surveyed in 1915, thence running North 19 degrees 45 minutes East 3510 feet to a boundary set in a field on the property of James B. Russell, thence with a right-angle or North 70 degrees 15 minutes West 922 feet to a boundary set on the East side of the State Road leading from Leonardtown to Hollywood, thence across the said road 40 feet, thence with same line North 70 degrees 15 minutes West 2810 feet to a boundary set on the property of J. Igns.

Hayden, thence with a right-angle or South 19 degrees 45 minutes West 4250 feet to a boundary set on the North side of the State Road leading from Leonardtown towards Washington, D. C., the Northwest boundary as surveyed in 1939, thence across the said road 50 feet, thence South 19 degrees 45 minutes West 4980 feet to a boundary set in a marsh on "Breton's Bay", thence in an easterly direction with said marsh and the shore of "Breton's Bay", to the southwest boundary of Leonardtown as surveyed in 1915.
