Commissioners of Leonardtown Annual Drinking Water Quality Report

IS MY WATER SAFE?

Last year, as in years past, your tap water met all U.S. Environmental Protection Agency (EPA) and state drinking water health standards. The Town of Leonardtown vigilantly safeguards its water supplies and once again we are proud to report that our system has not violated a maximum contaminant level or any other water quality standard.

Our Water utility staff consists of five licensed operators who have a combined experience of more than 60 years between them. Our operators have maintained educational training in the past year in an effort to keep up-to-date with the latest in water treatment techniques. Our goal is to give you the best quality water possible. The provision of quality water is an ongoing effort for the Commissioners of Leonardtown and its staff, and upon which we are continuously trying to improve.

In our continuing efforts to maintain a safe and dependable water supply, it may be necessary to make improvements to your water system. The cost of these improvements may be reflected in the rate structure. The Town sets its water rates so that the system pays for itself without a subsidy from property tax revenues. In this way, the cost of the water service can be borne by those who actually use water rather than just by the property owners.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. WHERE DOES MY WATER COME FROM?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

The source of our drinking water is now the Patapsco Aquifer (November 2007) which lies about 800 feet below the earth's surface. An aquifer is a sort of underground river. Wells are drilled to tap the aquifer and pump water to the surface for distribution. The Maryland Department of the Environment's Water Supply Program (WSP) has conducted a Source Water Assessment for the Leonardtown water supply and has determined that it is not susceptible to contaminants originating at the land surface due to the protected nature of confined aquifers. The water supply is, however, susceptible to naturally occurring arsenic (based on the new EPA standard). WHY ARE THERE CONTAMINANTS IN MY DRINKING WATER?

Wastewater Treatment Plant

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800-426-4791).

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations,
 urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limits the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

HOW CAN I GET INVOLVED?

The Town's residents can all play a part to ensure the quality and supply of our water. Being conscious of how you utilize this precious resource will help the Town ensure the reliability of our water supply. The Commissioners of Leonardtown along with the staff of the Utilities Department remain dedicated to providing the best quality water possible for the Town's residents.

OTHER INFORMATION

Water Conservation: While the Town presently has a sufficient water supply, the Commissioners of Leonardtown urge every citizen to exercise good conservation practices in the use of this precious resource. ADDITIONAL INFORMATION FOR ARSENIC

Some people who drink water containing arsenic in excess of the MCL over many years could experience skin damage or problems with their circulatory system and may have an increased risk of getting cancer. In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limits the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily cause for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

IMPORTANT DRINKING WATER DEFINITIONS

The following tables contain scientific terms and measures, some of which may require explanation.

<u>TERM</u>	<u>DEFINITION</u>
Avg	Regulatory compliance with some MCLs are based on running average of monthly samples.
MCL: Maximum Contaminant Level	The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
Level 1 Assessment	A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
MCLG: Maximum Contaminant Level Goal	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
Level 2 Assessment	A Leve 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.
MRDL: Maximum residual disinfectant level.	The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
MRDLG: Maximum residual disinfection level goal	The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
NA	NA: not applicable
mrem	millirems per year (a measure of radiation absorbed by the body).
ppb	micrograms per liter or parts per billion – or one ounce in 7,350,000 gallons of water.
ppm	milligrams per liter or parts per million – or one ounce in 7,350 gallons of water
Treatment Technique or TT	A required process intended to reduce the level of a contaminant in drinking water.
