LEONARDTOWN COMPREHENSIVE ZONING MAP

FOR the purpose of adopting an update and revision of the Comprehensive Zoning for the Town of Leonardtown

EXPLANATORY STATEMENT: The Town Planning and Zoning Commission has recommended, and the Town Council has adopted, an update and revision to the Town's Comprehensive Land Use Plan based upon changes in circumstances and conditions that have taken place in and around the Town, the County and the State since that Plan last was adopted in 1998. As a result of the revisions and update to the Comprehensive Land Use Plan the Planning and Zoning Commission has recommended, and the Town Council desires to adopt, an update and revision to the Town's Comprehensive Zoning Map. Now, therefore.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF SECTION I. LEONARDTOWN that the Comprehensive Zoning Map for the Town of Leonardtown prepared by the Maryland Department of State Planning dated March, 2004 and recommended by the Town Planning and Zoning Commission, a copy of which is appended to this Ordinance, is hereby adopted as the Comprehensive Zoning Map for the Town.

SECTION II: AND BE IT FURTHER ORDAINED, that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the affirmative vote of four-fifths of the whole Council after veto by the Mayor.
