AN ORDINANCE for the purpose of approving certain amendments to the Town of Leonardtown Critical Area Map; providing that the title of this Ordinance shall be deemed a fair summary; and generally relating to the Town of Leonardtown Critical Area Map.

RECITALS

WHEREAS, pursuant to Md. Code Ann., Nat. Res. § 8-1808, the Mayor and Commissioners of the Town of Leonardtown (the "Mayor and Commissioners") have adopted a Critical Area Program for the Town of Leonardtown (the "Town"), which is set forth in Chapter 60 of the Code of the Town of Leonardtown, and a Town of Leonardtown Critical Area Map (the "Critical Area Map"); and

WHEREAS, pursuant to Code of Maryland Regulations ("COMAR") 27.01.11.06, the Maryland Department of Natural Resources ("DNR") and the Critical Area Commission for the Chesapeake and Atlantic Coastal Bays Commission (the "CAC") have provided the Town with amendments to the Critical Area Map as shown on the "Proposed Critical Area Summary Draft Map, Leonardtown, MD," (the "Draft Map") which is attached hereto and incorporated by reference herein, which identifies the shoreline and landward boundary of tidal wetlands by use of the most recent aerial imagery and ensures that the 1,000 foot Critical Area boundary is accurate to a scale of 1 inch = 100 feet; and

WHEREAS, the Mayor and Commissioners have reviewed DNR and the CAC's amendments to the Critical Area Map as shown on the Draft Map, held a public hearing thereon in accordance with COMAR 27.01.11.06, and have determined that the amendments shown on the Draft Map are accurate and that the Critical Area Map should be amended to incorporate the same; and

WHEREAS, the Mayor and Commissioners find that approving the amendments to the Critical Area Map as set forth herein would be in the best interest of the health, safety, and welfare of the citizens of the Town.

SECTION I. BE IT ORDAINED BY THE MAYOR AND COMMISSIONERS OF THE TOWN OF LEONARDTOWN that the amendments to the Town of Leonardtown Critical Area Map shown on the "Proposed Critical Area Summary Draft Map, Leonardtown, MD" attached hereto and incorporated by reference herein are approved and adopted.

SECTION II. AND BE IT FURTHER ORDAINED that the Town of Leonardtown Critical Area Map, as amended pursuant to Section I herein, shall be submitted to the CAC for approval in accordance with COMAR 27.01.11.06.G and, upon final approval thereof by the CAC, shall be deemed to be adopted as the official Critical Area Map for the Town.

SECTION III. AND BE IT FURTHER ORDAINED that the recitals to this Ordinance are incorporated herein and deemed a substantive part of this Ordinance.

SECTION IV. AND BE IT FURTHER ORDAINED that, if any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court or competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance, it being the intent of the Mayor and Commissioners that this Ordinance shall stand, notwithstanding the invalidity of any section, subsection, sentence, clause, phrase, or portion hereof.

SECTION V. AND BE IT FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION VI. AND BE IT FURTHER ORDAINED that the title of this Ordinance, or a condensed version thereof, shall be deemed to be, and is, a fair summary of this Ordinance for publication and all other purposes.

SECTION VII. AND BE IT FURTHER ORDAINED that this Ordinance shall become effective twenty (20) days following approval by the Mayor or passage by the affirmative vote of four-fifths of the whole Commissioners after veto by the Mayor.
