

RESOLUTION NO. 3-20

A Resolution of the Council of the Town of Leonardtown to Designate a Resident Agent Pursuant to Md. Code Ann., Local Gov't § 1-1301

WHEREAS, pursuant to Md. Code Ann., Local Gov't § 1-1301, political subdivisions of the State of Maryland are required to file with the State Department of Assessments and Taxation a designation of resident agent on whom process and notice may be served under certain circumstances; and

WHEREAS, there is no provision of the Charter of the Town of Leonardtown or the Code of the Town of Leonardtown designating an individual to accept service of process and notices required by law for the Town; and

WHEREAS, the Council of the Town of Leonardtown has determined that it is in the best interest of governmental efficiency that legal counsel for the Town be designated as resident agent.

NOW THEREFORE BE IT RESOLVED, by the Council of the Town of Leonardtown:

1. The recitals to this Resolution are incorporated herein and deemed a substantive part hereof.
2. Patrick W. Thomas, Esq. is hereby designated as the resident agent for the Town of Leonardtown.
3. The Town Administrator and/or other appropriate officials of the Town are hereby fully authorized and directed to file this resident agent designation, and future changes thereto, with the appropriate department or agency of the State of Maryland.
4. This Resolution shall become effective immediately upon its adoption.
